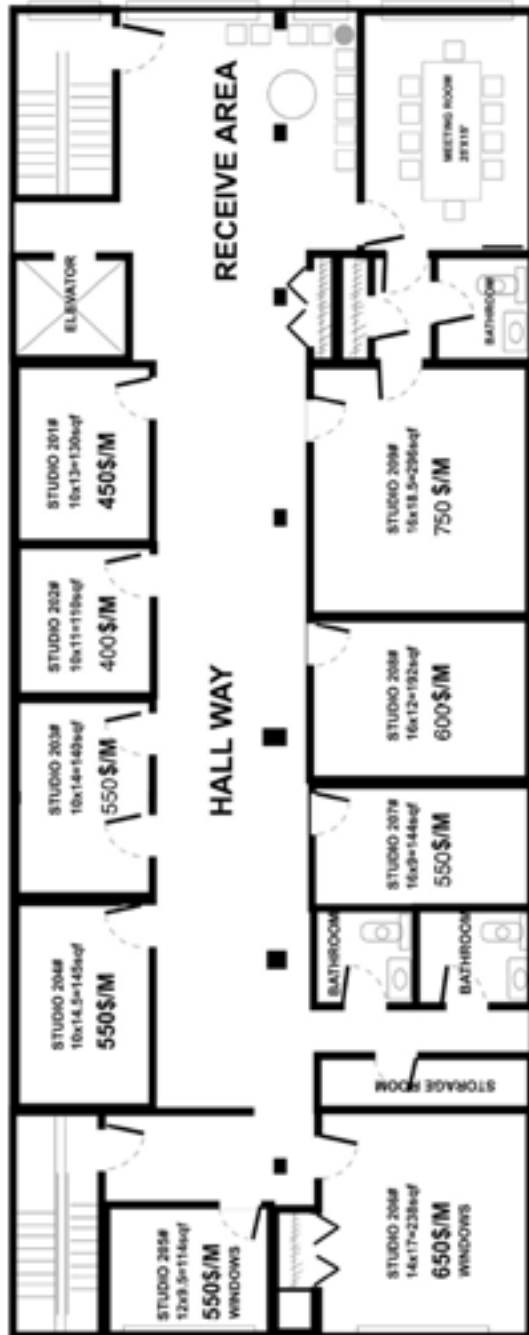

Floor Plan

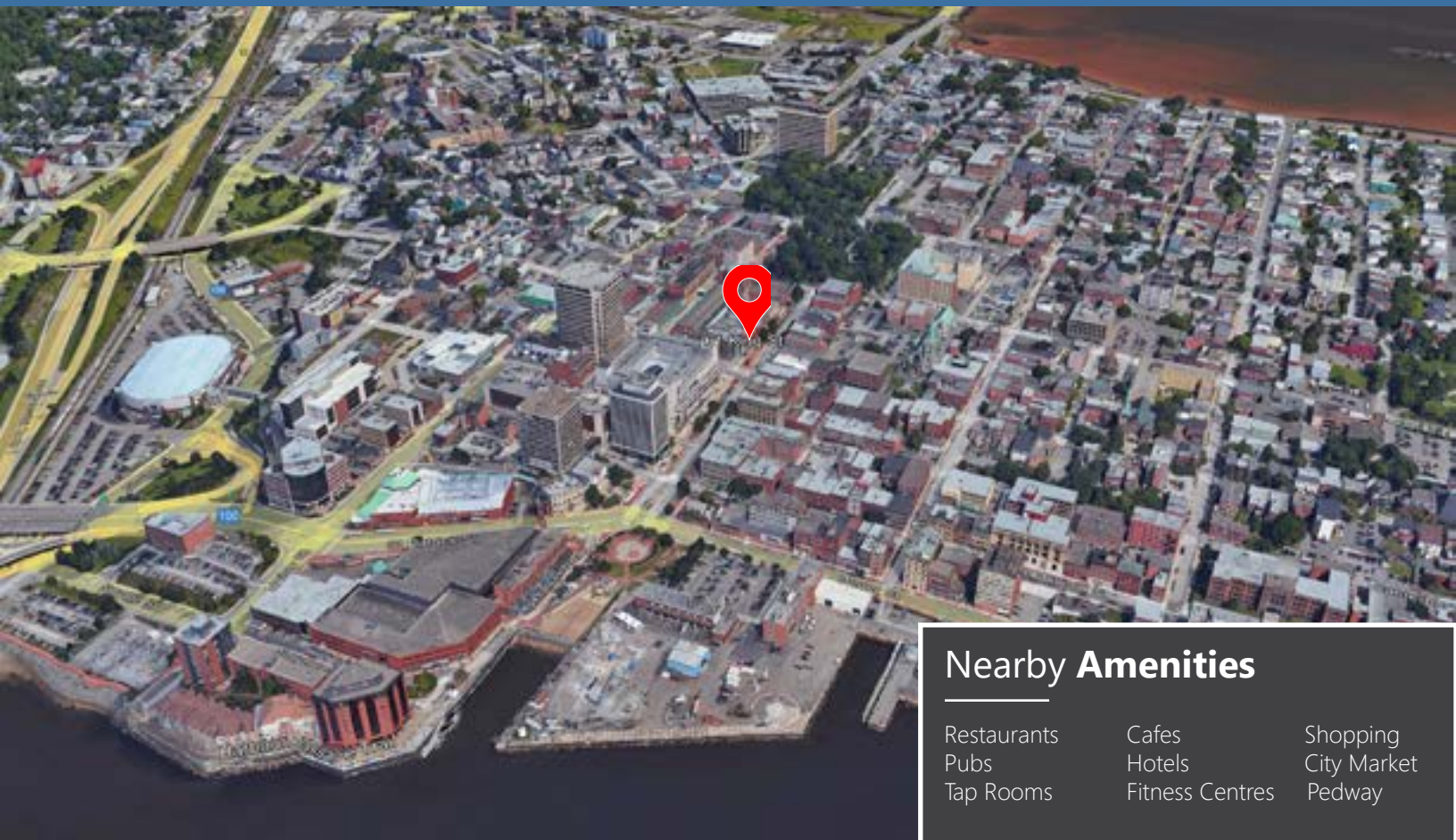
